Feeding Greene's mission is to see that no one goes to bed hungry in Greene County. We are a member of the Blue Ridge Area Food Bank (under the umbrella of Feeding America) and provide free USDA, purchased, and donated food to needy families. We seek and accept donations from local businesses, civic groups, churches and individuals. We are committed to making Feeding Greene a sustainable resource in our community and consider it a privilege to offer this service to families in Greene County.

Our "Client Choice Program" is open every Tuesday and Thursday from 10am-12noon and the 3rd Wednesday of every month from 4pm-6pm for families to receive free USDA, purchased, and donated food once a month and produce, breads, and other perishables twice a month. Eligibility for USDA food is determined according to the USDA Emergency Assistance Program Guidelines (TEFAP) and is based on income and family size. All families choose from an assortment of canned foods, dry goods, cereal, peanut butter, produce, beverages, meats, breads, and pastries. We have an average of 24 volunteers/month working an average of 356 hours/month picking up, receiving, storing, and distributing food. With the help of these committed volunteers in 2016 we were able to distribute 85,869 lbs of USDA food at a value of \$143,401; 63,562 lbs of donated food from 4 area BRAFB partners at a value of \$106,149; and 29,652 lbs of donated food from churches, businesses, civic groups, & individuals in our community at a value of \$49,519. This is a total value of \$299,069 (\$1.67/lb based on Feeding America Product Valuation study.) We served 1,856 families and 4,858 individuals in 2016. Of the individuals served, 732 were Elderly 60 and older, 1,543 were Children age 18 and under, and 2,583 were Adults aged 19-59. Each individual is counted each month their family comes in for assistance.

Our "Meat of the Month Program" was started in an effort to ensure that families receive meat products each month along with the other food choices in our "Client Choice Program". This program is actually a part of our "Client Choice Program" and the same families and individuals served are the same as mentioned in 4a and are not tracked separately. For several years we were only able to provide free USDA or donated meats from BRAFB partners when they were available. We started this effort by seeking donations from local grocery stores and received two gift cards totalling \$600. This was used to purchase 600 1-pound packages of meat which was distributed to families. This is a \$1,002 value at \$1.67 per pound. We have currently approved a \$300/month budget to purchase food for this initiative. We will also be seeking additional funding throughout the year to support this program. We feel it is very important to be able to provide this essential protein to our families for nutritional reasons. The only items tracked separately in this program are food purchases from gift cards and food purchases directly from local grocery stores.

Our "Christmas Meal Program" provides a ham for families in December. We handed out 200 hams (1,813 lbs) in 2016 to 200 families. At \$1.67 per pound this is a value of \$3,028. We are looking to expand this program to include other food items to complete a meal for Christmas. We have just budgeted \$300/month for this program for 2017 and will also be seeking additional funding.
