Feeding Greene's mission is to see that no one goes to bed hungry in Greene County. We are a member of the Blue Ridge Area Food Bank (under the umbrella of Feeding America) and provide free USDA, purchased, and donated food to needy families. We seek and accept donations from local businesses, civic groups, churches and individuals. We are committed to making Feeding Greene a sustainable resource in our community and consider it a privilege to offer this service to families in Greene County.

Our "Client Choice Program" is open every Tuesday and Thursday from 10am-12noon and the 3rd Wednesday of every month from 4pm-6pm for people to receive free USDA, purchased, and donated food once a month and produce, breads, and other perishables twice a month. Eligibility for USDA food is based on The Emergency Food Assistance Program (TEFAP) guidelines and is based on automatic qualifiers OR household size and income. Families choose from an assortment of canned foods, dry goods, cereal, peanut butter, produce, beverages, meats, breads, & pastries. We have an average of 26 volunteers/month working an average of 526 hours/month picking up, receiving, storing, and distributing food. With the help of these committed volunteers in 2018 we were able to distribute 212,678 pounds of food at a value of \$357,299. This includes USDA, purchased, and donated food from Blue Ridge Area Food Bank, food from 5 area BRAFB partners, food from churches, businesses, civic groups & individuals in our community, as well as food we purchase from local grocery stores. Food is valued at \$1.68/lb and is based on Feeding America's independent studies. We served 2,025 households and 5,528 individuals in 2018. Of the individuals served, 1,124 were Elderly ages 60 and older, 1,696 were Children ages 17 and under, & 2,708 were Adults ages 18-59. Each individual is counted each month their family comes in for assistance in accordance with USDA reporting requirements.

4b (Code:) (Expenses \$ 51,597 including grants of \$ 5,000) (Revenue \$)

Our "Meat of the Month Program" is designed to ensure that families receive meat products each month along with the other food choices in our "Client Choice Program". This program is actually a part of our "Client Choice Program" and the same families and individuals served are the same as stated in 4a. We feel this is an important protein item that our families often struggle to provide for their families and we have put a major emphasis on providing this essential protein each month for nutritional reasons. We obtain some of our meat from Blue Ridge Area Food Bank as well as Walmart and 3 local Food Lion stores as part of BRAFB's Partner Pick Up Program. We also purchase meat and eggs from local grocery stores, accept venison from the Hunters for the Hungry Program, and seek grants and donations to help with this expense. This year we received a donation of 60 dozen eggs and a \$5,000 grant from BAMA Works to use towards the purchase of protein items. The families we serve have been very excited about this program and we do believe it has encouraged more families to seek food assistance from us. In 2018 we obtained 25,129 pounds of meat at a value of \$42,217.

Our "Christmas Meal Program" provides a special meat item and other food items to complete a meal for Christmas for our families in the month of December. In 2018 we handed out 200 large turkey breasts and Holiday Boxes (provided by local Food Lion Stores) to families that came into our pantry. These families also received other food items from our "Client Choice Program" and "Meat of the Month Program" to help complete a meal for the holidays. We don't currently have space to store and distribute totally separate holiday food items, so we only track the weight of the meat and the special holiday boxes donated to us from Food Lion for this program. In 2018, we tracked 5,304 pounds of food for a value of \$8,911.
