FEEDING GREENE'S MISSION IS TO SEE THAT NO ONE GOES TO BED HUNGRY IN GREENE COUNTY, VIRGINIA. WE ARE A MEMBER OF THE BLUE RIDGE AREA FOOD BANK (BRAFB) (UNDER THE UMBRELLA OF FEEDING AMERICA) AND PROVIDE FREE USDA, PURCHASED, AND DONATED FOOD TO NEEDY FAMILIES. WE SEEK AND

OUR "CLIENT CHOICE PROGRAM" IS OPEN EVERY TUESDAY, THURSDAY AND SATURDAY FROM 9 AM TO 12 NOON AND OFFERS FREE USDA FOOD, AND PURCHASED AND DONATED PRODUCE, BREADS, AND OTHER PERISHABLES ONCE A WEEK TO QUALIFIED FAMILIES RESIDING IN VIRGINIA. ELIGIBILITY FOR USDA FOOD IS BASED ON THE EMERGENCY FOOD ASSISTANCE PROGRAM (TEFAP) GUIDELINES AND IS BASED ON AUTOMATIC QUALIFIERS OR HOUSEHOLD INCOME. FAMILIES CHOOSE FROM AN ASSORTMENT OF CANNED FOODS, DRY GOODS, CEREAL, PEANUT BUTTER, PRODUCE, BEVERAGES, FROZEN MEATS, FRESH MILK, DAIRY PRODUCTS, BREADS AND PASTRIES. WE HAVE AN AVERAGE OF 100 VOLUNTEERS PER MONTH WORKING AN AVERAGE OF 1,500 HOURS PER MONTH PICKING UP, RECEIVING, SORTING, STOCKING AND DISTRIBUTING FOOD. WITH THE HELP OF THESE COMMITTED VOLUNTEERS IN 2021 WE WERE ABLE TO DISTRIBUTE 677,150 POUNDS OF FOOD AT

OUR "HOME DELIVERY PROGRAM" PROVIDES FOOD TO FAMILIES WITH NO TRANSPORTATION (AND OFTEN DISABILITIES) ON THE FIRST AND THIRD WEDNESDAY OF EACH MONTH. WE DELIVER PRE-BOXED GROCERIES TO FAMILIES IN GREENE COUNTY, OFTEN FILLING BOXES TO MEET SPECIFIC DIETARY NEEDS. THESE FAMILIES ALSO QUALIFY BY INCOME FOR TEFAP FOOD BUT WE OFTEN PURCHASE LOW SUGAR AND LOW SODIUM FOODS FOR THIS PROGRAM. WE CURRENTLY HAVE 15 DELIVERY ROUTES WITH VOLUNTEERS RANGING FROM YOUNG ADULTS TO OUR RETIRED COMMUNITY. WITH THE HELP OF THESE COMMITTED VOLUNTEERS, IN 2021 WE WERE ABLE TO DISTRIBUTE 110,012 POUNDS OF FOOD AT A VALUE OF \$196,921. WE MADE 982 DELIVERIES TO FAMILIES IN GREENE COUNTY IN 2021. WE ALSO PARTNERED WITH THE BLUE RIDGE HEALTH DEPARTMENT TO PROVIDE GROCERIES AND CLEANING SUPPLIES TO FAMILIES WITH COVID UNABLE TO LEAVE

OUR "BACKPACK PROGRAM" IS NEW TO US THIS YEAR AND IS DESIGNED TO MEET THE NEEDS OF OUR CHILDREN IN OUR COMMUNITY. COVID BROUGHT A LOT OF ATTENTION TO THE INCREASED NEED FOR FOOD THAT MANY FAMILIES WITH CHILDREN WERE EXPERIENCING. AS A RESULT, WE OFFERED SPECIAL "KIDS BAGS" AT THE ONSET OF COVID AND REPLACED THOSE BAGS WITH OUR CURRENT BACKPACK PROGRAM WHICH PROVIDES KID-FRIENDLY FOOD FOR CHILDREN TO PREPARE THEIR OWN MEALS OVER THE WEEKEND. THIS PROGRAM RUNS DURING THE SCHOOL YEAR WITH THE HELP OF APPROXIMATELY 20 VOLUNTEERS EACH MONTH. WITH THE HELP OF THESE COMMITTED VOLUNTEERS, IN 2021 WE WERE ABLE TO DISTRIBUTE 8,364 POUNDS OF FOOD AT A VALUE OF \$14,972. IN THE SUMMER MONTHS WE PROVIDE SUMMER KIDS BAGS WHICH BLUE RIDGE AREA FOOD BANK MAKES AVAILABLE TO US. IN 2021, WE PROVIDED 1,394 BACKPACKS TO 1,394
